Gary VanDyke—Member

BOARDS OF CAERNARVON TOWNSHIP

The Planning Commission is comprised of 5 Volunteer members that meet monthly to review land development and subdivision project proposals and follow their status as they move through the approval process. The members also review the Zoning Hearing Board Applications and offer their comments to the Zoning Hearing Board for their consideration in rendering a decision to the applicant. Our Planning Commission is also where the work starts in reviewing and updating the Township Zoning Ordinance or Township Comprehensive Plan. The board has spent many hours reviewing past and present ordinances of Caernarvon, as well as other area townships to help them come to decisions in any updates of the township's regulations.

The current members of this board are Marlin Mast, Gerald Eberly, Lewis Leid, Dale Horning and Frank Deim. They are always interested in hearing from the residents, so join them for one of their meetings.



Three volunteer members compose the **Caernarvon Township Zoning Hearing Board** which meets on a monthly basis, as needed. Lloyd Simmers, Bob Lauffer and John McElwee make up the board that hears the applications for zoning hearings made by property owners within the township and renders the decision.

These applications include variance requests from the terms of the Zoning Ordinance, special exceptions and appeals from the determination of the Zoning Officer, Barry Wagner. Each of these requests must be accompanied by supporting documentation and are reviewed by the Township Supervisors and Planning Commission at their regular meetings before the hearing is held.

“CAERNARVON TOWNSHIP, AGRICULTURE & OUR FUTURE” (UPDATE ON AGRICULTURE AND FARMLAND PRESERVATION)

In 2007, Caernarvon Township established, by resolution, the **Ag Advisory Committee**. Its seven members include Raymond Brubacher, Paul Hartz, Raymond Lee King, Lewis Leid, Ernie Mast, James Sensenig, and Gary VanDyke.

The AAC, in partnership with the Ag Preserve Board and the Lancaster Farmland Trust, is assisting farmers and the township in placing more agriculture acres in ag security and under preservation. Since 2006, 648 acres have been Added to Caernarvon's Ag Security area. In 2008, 192 acres were placed under preservation, and for 2009, preservation easements should include almost 300 acres.

Two more farms are already on the list for preservation in 2010. If you are interested in attending an Ag Advisory Committee meeting, they are every other month (even months) on the 3rd Thursday, at 7 pm in the Fire Hall's Township Meeting Room. You may call the AAC at 717-445-7978, the Ag Preserve Board at 717.278.8355, or the Lancaster Farmland Trust at 717-687-8484, if you have any inquiries.

The Caernarvon Preservation Fund (CPF), established in 2001, is used by the Lancaster Farmland Trust to Preserve farmland only in Caernarvon Township. The Trust preserved 85

acres in 2008, and 94 acres in 2009.

Donations to the Trust that are designated for the CPF will be matched by Caernarvon Township on an annual basis. Tell your friends, tell a tourist, and anyone interested in preserving farmland and promoting agriculture. With the CPF, we can all partner for preservation.

On October 21st, at the Lancaster Farmland Trust's annual banquet, Caernarvon Township, along with the Chester County Solid Waste Authority, were both presented the 2009 Amos H. Funk Spirit of Cooperation Award. The award was developed in 1999 to recognize cooperative efforts to promote farmland preservation. Now at the age of 97 and regarded as the father of farmland preservation in Lancaster County, and likely the nation, Amos Funk is a tireless leader in land, soil, and water conservation. He spent his lifetime reaching out to a broad spectrum of farmers and community leaders to promote farmland preservation in Lancaster County. The award is given annually to an individual, business, or entity that exhibits an extraordinary measure of cooperation that helps Lancaster Farmland Trust succeed.

Thank you to all the businesses, residents, and landowners who participate in making Caernarvon Township an agriculturally secure area, and a better place to live and work.

WINTER WEATHER



Winter is upon us, we have already experienced several weather events. Cooperation of residents is needed and appreciated for efficient snow removal efforts by our roadcrew. We strive to maintain clear, safe roadways for our residents and passing motorists while working as efficiently as possible.



To help us you can:

1. Do not park on any township roads.
2. Wait for the snowplows to finish before cleaning the end of your driveway.
3. When clearing your driveway, do not deposit your snow into the roadway. This causes hazardous conditions.
4. Cul-de-sacs and storm drains are the final areas to be cleaned up after storms. Please remember that we cannot be everywhere at once. We plow all roads in order of priority, main roads are maintained first.



MAILBOXES !!!



The township receives many complaints about mailboxes being damaged during storm events. We try to be careful plowing around mailboxes, but there are a few things you can do to help your mailbox survive the winter.

Check your mailbox and post to be sure it is sturdy, not rotten, the post is secure and tight, and the box is securely attached to the post. Any loose parts will lead to failure when the weight of the snow is pushed against the box or post. Is your mailbox sturdy? Plastic mailboxes tend to become brittle and can shatter on impact. New metal mailboxes offer very little in the way of strength. The door is key to the structure of the mailbox, so make sure the door closes tightly and stays shut. If you have a decorative mailbox you may want to think about removing it for the winter months and replacing it with a basic mailbox.

ROAD PROJECTS FOR 2010 IN CAERNARVON TOWNSHIP

The township has approved their 2010 budget including the following road projects. Narvon Road will be paved as the last step in completing the project we began in 2009. Seal coat is proposed for Brendel, Gehman, Mill, Nolt and Windsor Roads.

STORMWATER, when it rains it pours. The edges of the roadways are designed and constructed to keep the water off of the roads which is critical to maintaining the integrity of the roadways. When residents place leaves, branches, grass clippings or change the swale area the water is directed to other areas. Residents are responsible for disposing of their yard waste and are not permitted to place anything within the roadside swales maintained by the township.

When paving or changing a driveway, please be sure to keep a swale at the connection to the township road to keep the water where it belongs. If you aren't sure about what you need to do or just have questions, please feel free to contact the township Roadmaster, Terry Hartranft through the township office at 717-445-4244.



HAPPENINGS AND HORIZONS

The office has been working with a local web designer to make the website as user friendly as possible. Copies of most forms will be posted on the site, a calendar with meetings and community activities posted, and important contacts are just a few of the items that are included. Our goal is to make as much information as possible easily accessible to our residents.

TOWNSHIP TRASH PROGRAM

The Township Trash Program has been operated on Saturday mornings for over 20 years. This program offers trash disposal at a reasonable cost to all township residents. Currently program participants can dispose of 5 bags of trash and all their recycling at the township garage from 7 to 11 AM every Saturday. During March and April the trash hauler that has the current contract will be selling participant stickers at the garage on Boot Jack Road. The applications can also be picked up at the township office and will be posted to the website but the stickers can only be purchased from the trash hauler.



Reduce – Reuse – Recycle

Important words in this township as we are the host township of the Lanchester Landfill. Every item someone recycles is one less item in the landfill. Please think before you throw something that can be reused into your trash can. Rinse out plastics and metal cans. Newspapers are accepted as recycling and many local farms are always collecting newspapers to use as bedding for farm animals. All residents of Caernarvon can also take recycling materials to the Lanchester Landfill recycling facility.

Reusable shopping bags --- Stop by the township office and pick up a free Caernarvon Township Reusable Shopping Bag. The township is handing out these bags to promote reducing trash being generated by the township. Please do your part.

SIDEWALKS PLANNED TO LINK CHURCTOWN TO HPF

The township is planning a big project this summer to link Churchtown to Historic Poole Forge. Sidewalks! For the past several years the township has been discussing the installation of sidewalks from the current sidewalks along Main Street west to the Historic Poole Forge property line. 2010 is the year we are hoping to complete this project which will allow visitors to the area and residents walk safely between Churchtown and the township owned community park.

THE LANCASTER FARMLAND TRUST PARTNERSHIP WITH CAERNARVON TOWNSHIP

Lancaster Farmland Trust is proud to partner with Caernarvon Township to preserve a fourth Caernarvon farm for future generations. The partnership began in 2001 when the Township and the Trust joined to establish the Caernarvon Fund, a pool of funds set aside through the Trust for the preservation of Caernarvon farms. In this innovative arrangement, the Chester County Solid Waste Authority makes an annual contribution to the Fund at the recommendation of the Township. The Township also matches private contributions to the Fund, which people can send to the Trust throughout the year.

Since its inception, the Caernarvon Fund has allowed for the preservation of three farms for a total of 178 acres of farmland. The Trust recently began a fourth project to preserve a 78-acre farm, which will bring the total to more than 250 acres preserved through this partnership.

Lancaster Farmland Trust is a private, non-profit organization striving to preserve the rich and productive farmland of Lancaster County. The Trust works throughout the county to support good stewardship of the land and to encourage a thriving agricultural economy, recognizing that Lancaster's farm heritage enriches the lives of all citizens. The organization looks forward to preserving many more farms in Caernarvon Township.

LANCASTER COUNTY PRESCRIPTION DRUG DISCOUNT CARDS

Lancaster County residents have saved more than \$150,000 on over 8,500 prescription medications since the Lancaster County Prescription Drug Discount Card Program was initiated in May 2009. And now realizing this saving is easier than ever. If you have not been able to pick a card up from the Caernarvon Township office, you can now print an active Lancaster County Prescription Drug Discount Card online. To use this new tool, visit www.caremark.com/naco and select "Print a card". You will then be prompted to enter your zip code. Select 'Next' and an ID card will be generated for your immediate use at participating pharmacies.

The program, offered by the Lancaster County Board of Commissioners, provides a discount on prescription drugs not covered by another health plan at any of the 91 participating pharmacies in Lancaster County or 59,000 participating pharmacies Nationwide.

The cards are FREE and there are no eligibility requirements, enrollment forms, or membership fees to use the Lancaster County Prescription Drug Discount Card program. Simply pick up a card and take it to a participating pharmacy to receive a discount. One card can be used for the whole family!

CONSERVANCY CLOSES ON SECOND PHASE OF WELSH MOUNTAINS NATURE PRESERVE

Lancaster, PA – The Lancaster County Conservancy is excited to announce the acquisition of the second phase of what will be a nearly 900 acre Welsh Mountain Nature Preserve in East Earl and Salisbury Townships. This parcel, which totals over 191 acres, was purchased with funds from the PA Department of Conservation and Natural Resources, Caernarvon and East Earl Townships, and Lancaster County.



The Preserve lies in the Pennsylvania Highlands Region. The Highlands are federally recognized as lands that are especially ecologically sensitive and a high priority for protection, and have also been a focus for the County for a number of years.

The planned 404 acre third phase of the project, with an anticipated close date of December 31, 2010, is across Gault Road from Phases 1 and 2. The first two phases are adjacent to Money Rocks County Park. The completion of this final phase, in conjunction with the County Park, will result in over 1100 acres of contiguous forest land, protecting unique interior forest ideal habitat for wildlife, and providing ideal protection for water and air quality, and opportunities for expanded public recreation.

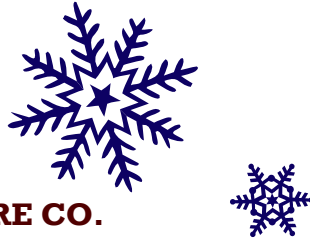
While a lot of progress has been made, the Conservancy is still short of the necessary funds to complete this project. This is a truly unprecedented and vital land protection project in Lancaster County, and we need everyone in the community to come together to make it happen.

County funding for natural lands purchase and protection was cut from \$1 million to \$525,000 in 2009, and is in jeopardy of being cut completely in 2010. The Conservancy is asking for the public's help in working to restore full funding for land protection at the County level. You can help by writing to your County Commissioners and asking them to restore funding for the protection of natural lands back to the previous level of \$1 million per year. Every penny of this money is necessary to finish the important work in the Welsh Mountains that was started over five years ago. Writing a letter is a simple but powerful way you can let the County Commissioners know that you support natural lands protection in Lancaster County.

Remember – these are our forests, and they hold our collective history. Join us in the fight to save them for all of us. Offers Winter Safety Tips

**for the
Caernarvon Township Community**



Cold winter weather is fast approaching, and with it comes a variety safety hazards both indoors and out. To help ensure everyone in our community stays safe and warm this season, the members of the Caernarvon Fire Company offer the following tips.

EMERGENCY ACCESS

Emergency personnel and equipment are ready to serve you. Can we find you?

- Visibly mark your residence and business with a reflective address sign. Signs can be purchased by calling the Caernarvon fire station at 717-445-7310.
- Trim trees overhanging your driveway to a minimum of 12 ft. clearance for fire apparatus.
- Keep sidewalks clear of snow and ice.

HOME HEATING

Colder weather means it's time to turn on your furnace or other heating device. But take care, December, January, and February are the leading months for home fires, and heating devices are often the culprit. With proper precautions you'll be safe and warm this season.

- Install a smoke detector and carbon monoxide alarm near your bedrooms and on each floor.
- Know the symptoms of carbon monoxide poisoning: headache, fatigue, nausea, dizziness, and shortness of breath. Keep heating and appliance vents clear of obstructions, drifting snow and bushes to provide proper ventilation.
- Your wood-burning fireplace should have a sturdy fire screen in place. Keep the area around the fireplace clean. Dispose of ash outside and in a fire-safe container.
- Make sure your chimney and flue are inspected each year and cleaned, if needed. Burn seasoned dry wood. Never burn cardboard boxes or trash, as they can spark a chimney fire.
- Keep portable space heaters at least three feet from anything that can burn, including bedding, furniture, and clothing. Never drape clothing over a space heater to dry.
- Never use your range or oven to heat your home, even for a short time.

DRIVING SAFETY

Snow, ice, and extreme cold can make driving treacherous. Before winter, make sure your car is ready for the season with a tune up, snow tires or tires with good tread, a charged battery and sufficient anti-freeze.

- If you must travel in bad weather, drive slowly and let someone know your route and anticipated arrival time.
- Brake gently; leave yourself plenty of room to stop. Turn on your lights to increase your visibility to other motorists.
- Use extreme caution when passing snowplow and salt trucks. The drivers have limited visibility and you're likely to find the road in front of them worse than the road behind.



HOLIDAY FIRE SAFETY

Make this holiday season a happy time by practicing these safety habits.

- Never leave a burning candle unattended.
- Inspect holiday lights each year for frayed wires, broken plugs, sockets, etc. Never overload electrical outlets. Unplug lights before leaving home or going to sleep.
- Start holiday cooking with a clean stove and oven. Never leave cooking unattended.
- Have a fire extinguisher available and know how to use it.

This is only a sample of the safety precautions we must take during the winter months. Safety is a personal responsibility. If you are in doubt, think twice before doing anything that may prove hazardous to yourself, your property or those around you.

In 2009 there were not a lot of noticeable changes to the park. A new roof was put on the covered bridge and a monument to the iron forge was approved and erected. We had five successful events: the Easter Egg Hunt, the 150th Covered Bridge Party, the Car Cruise, the annual Heritage Day Event and the recent Christmas at the Iron-Masters event in the Mansion.

But, a great deal was accomplished behind the scene. The Restoration Committee completed work on a long-range plan, an administrator was hired, a clear budget procedure was established, the spouting on the mansion was repaired, and we published our first annual newsletter and our first cookbook. Historic Poole Forge, Inc. is making plans for the following in 2010: Establish a fundraising organization to restore the mansion; replace the waterlines throughout the park; place a bridge between the pavilion area and the playing fields; install a drainage system for the field; add additional parking around the park; and continue to plan the stream bank restoration from Route 23 to the Lime Kilns.

Historic Poole Forge Park is a volunteer driven undertaking. Our most valuable asset is our volunteer. We strive to make it a fun place to share a common experience. So **thank you** again, all you hardworking folks.
